The president reported that currently the boosters are looking at a potential \$2200 surplus for our standing budget! This is due to new policies and procedures, especially with concessions. The moonpies fundraiser total income was \$16,406.14 with an expense of \$11,383.13 for a net of 5,023.01. This year concessions had a net of \$15,168.81. The income was about \$2000 less than last year due to less home playoff games. While the income was \$26,810.22, the expenses were considerably less this year at only \$11,641.41. Currently the students' candy sales have brought in \$1,557.90 before expenses.

Band Director's Report:

Senior Clinic auditions were last week with two musicians auditioning. Jaron Dangler was invited to represent SCHS in the 9th and 10th band as a baritone on Feb 7-8.

March 17 will be the Solo and Ensemble night at 6pm at SCMS. All grades perform. The dinner theme has been Musicetti, hot dogs, and Taco Tuesday. It is on St. Patrick's day. We look forward to the social committee's work. Marching Band Fundamentals (including color guard) begins Jan 23 (every Thursday 3-15 to 5); however, the dates may change to Tuesdays. Tryouts are the week of April 27th: Mon-Tues guard; Drum Major 29th; Band April 30. Students must attend half of the days in order to audition. Students will perform at Valley Fest May 2. Perhaps the Band Banquet May 1st might be held at Chapel Hill.

Strawberries: Selling flat of 8lb (6.5lb last year) for \$20--8 clam shells through Dayton based Cameroon Swafford. Cost will be about \$8-10 with no taxes. The sale should begin tomorrow, Jan. 17. Cut off for all orders is Feb. 12
