## Budget Overview

Band Festival: The festival (with 10 bands) had an income of $\$ 10,859$. Our expenses were 5 , 618 . Thus our profit was $\$ 5,241$. Discussion ensued about how to continue to increase profit, including changing times.
Concession Stand/Meals: We have $\$ 700$ in product left. The sodas and food will move budgets in order to provide meals for kids. We asked SCHS if they wanted any at cost, but they did not. Would a booster check whether baseball might buy the Gatorade at cost or perhaps SCMS? Stephanie Higdon offered to check with baseball.
Moonpies/Orlando: We have sold $\$ 11,218.07$ in product. The payment to MoonPie is $\$ 10,710$. Thus we have only made a profit so far of $\$ 508$. Band families must turn in money for boxes out. We must push the 200+ cases left. Otherwise we will have to turn to the savings, and we wish to avoid such a resort. Currently, we are $\$ 3800$ in the red for our yearly budget but we are sitting on Moonpies to sell. Strawberries and candy bars are coming up. We have made \$26, 000 (and
change) in concession. We were short a playoff game this year, which is most likely the \$3,000 difference. The good news is due to new concession policies and contracts the expenses were drastically cut so this year's concession profit was $\$ 11,641$ !
Band Director's Report: Mr. Willis welcomed choral director Laura Hicks to the meeting. Square on the Square was successful and good promotion of our program in the community. It is events like these that promote the program and garner financial support throughout the year. He thanked the several boosters who came to the recent board meeting at the middle school. The board enjoyed seeing the kids, hearing them play, and reviewing our needs in the band room. The truck is still out on bid. The shop class cannot make the lockers, but Mrs. D Smith is looking into locker possibilities, too. Veterans Day received great remarks from our servicemen and women. We need the community behind us. The pep bands are well received by fans. Trip schedule will be available soon on all media. This week's rehearsal is as follows: Monday from $3-5$; Tuesday (a full dress rehearsal) from 3 to 5 ;Thursday from 3 to 5 , including prepping instruments and gear to leave the next morning.
Student Leadership Report: Emmalee Higdon reported that the band and guard had a lot of fun at TTU homecoming as well as Veterans Day. They are working on routines and memorizing songs for Orlando. It has been bittersweet for the seniors, but the trip is an exciting opportunity and celebration of all the hard work.

## Fundraising Committee Report:

We have launched our moonpies team competition and blitz. Barry is currently contacting candy sale rep. When we make it an unlimited number of cases, kids sell more.

## Social Committee Report:

McDonalds and Taco Bell sponsored our recent meals for SCMS home games. We have 12 more games so looking to churches and a few more business. Hardee's has agreed. The Christmas Concert is Dec. 17 at 6 pm . Barry has volunteered to take charge of the reception. Bev Goodwyn offered to help with decorations. The cafeteria will pack two breakfasts (Friday and Saturday) and two snacks for the Orlando trip.

## Uniform Committee Report:
